**WE AGREE TO THE FOLLOWING:**

- Rates for 2020 Outings are **\$40.00 per person WEEKDAYS** (\$36 for Golf & Cart, \$4 per player in Golf-Shop Certificates)
- Rates for 2020 Outings are **\$42.00 per person WEEKENDS** (\$38 for Golf & Cart, \$4 per player in Golf-Shop Certificates)
- Rates for **MONDAY OR TUESDAY** Outings are **\$32.00 per person** (\$28 for Golf & Cart, \$4 per player in Golf-Shop Certificates)

A **deposit of \$200.00** is required for new outings to reserve the requested date. Applications will not be accepted until the deposit is received in the form of a **CHECK, CREDIT CARD, CASH, OR MONEY ORDER**. The deposit will be returned in a timely manner, provided no damage is found to the Golf Carts, Golf Grounds and/or the Clubhouse. If the tournament is cancelled by the organization, the deposit will be **AUTOMATICALLY FORFEITED**.

**FULL PAYMENT (NOT INCLUDING THE \$200 DEPOSIT) MUST BE RECEIVED THE DAY OF THE EVENT, IN THE FORM OF A CASHIER'S CHECK, CASH, OR CREDIT CARD. FAILURE TO SUBMIT FINAL PAYMENT FOR YOUR EVENT WILL RESULT IN THE CANCELLATION OF THE TOURNAMENT BY THE GOLF PROFESSIONAL.**

5. The Tournament Chairperson is responsible for all arrangements.
6. The Westover Golf Commission reserves the right to cancel any future reserved tournaments at the discretion of the Commission. (Deposits shall be returned to applicants reduced by any outstanding liability to the Commission.)
